## KEYWEST'S SUBSIDIARY COMPLETES EXPANSION OF CANADIAN NETWORK

**Times Telecom, a wholly-owned subsidiary of Key West Global Telecommunications Berhad, adds 11 more cities to its existing five, covering all the major metropolitan areas of Canada**

**Kuala Lumpur – September 26, 2005** – Times Telecom Inc. (Times), a wholly owned subsidiary of Key West Global Telecommunications Berhad (Keywest) which is listed on the MESDAQ Market of Bursa Malaysia Securities Berhad, has completed expansion of its Canadian-wide network by adding 11 more cities to its coverage, namely Whistler, Abbotsford, Kelowna, Winnipeg, Hamilton, London, Ottawa, Kitchener, Montreal, Quebec City and Halifax. This brings Times' network coverage in Canada to 16 cities, including its original five cities in Vancouver, Victoria, Calgary, Edmonton and Toronto. Times offers international telephone-to-telephone and pc-to-phone long distance services, using Internet Protocol (IP) technology in addition to its traditional switch-based network.

With the network expansion, Times plans to begin offering its services to customers within the new cities such as dial up services, broadband phones, chain calling, voicemail, international roaming, call home (reversed charges), follow-me number, unified messaging and Times Mailbox. Subscribers may sign up for Times' services via the World Wide Web, and will have access to Times on-line conveniences for billing, call detail records and 24x7 technical support. Since entering the retail market in 2001, Times' subscriber base in Canada has grown steadily to 120,000 corporate and individual subscribers.

*"Regardless of how our customers wish to sign up, we will ensure that they are able to begin using our services within 72 hours. And because our network is global, Times will be well positioned to pass on significant cost savings to our customers, as well as conveniences not offered by other Telcos,"* said Andrew Lee, Sales and Marketing Manager for Times.

*"In addition to the above, the network expansion will also allow Keywest to offer other Telco's services. The network expansion will mean that Keywest has now expanded to 29 PoPs, a growth of 11 Pops,"* added Benjamin Wong, Chief Operating Officer of Keywest.

**Times Telecom Inc., is a long distance carrier of international voice and fax long distance services. To date, Times Telecom has established 16 PoPs (Points of Presence) within Canada and 2 POPs within Australia. Times utilizes traditional and packet-switching technology to send voice and fax over its network.
